Cooking Classes will be held twice a month for teens and adults starting in January. Please register in advance!






Down to Box with Farrell's is changing things up in 2025! Classes will be held on a weekly basis and fees are charged per class versus 8-week sessions.

Elissa, Brenda Kasaty, and I had the honor of representing DSAF in Washington, D.C. We joined five others from Nebraska and individuals from 24 other states for a record-breaking fly-in organized by the Global Down Syndrome Foundation. Our mission was to advocate for the DeOndra Dixon INCLUDE Project Act, which aims to secure funding for Down syndrome research and medical care at the National Institutes of Health (NIH). During our time on Capitol Hill, we were among 150 global self-advocates, family members, and researchers, as well as celebrities like Jamie Foxx, John C. McGinley, and Caterina Scorsone. Together, we filled the halls of Congress,

meeting with Senators to urge them to co-sponsor the bill and to vote in favor. Despite being the most commonly occurring genetic condition, Down syndrome has received the least funding from the National Institutes of Health.

DeOndra Dixon INCLUDE Project Act

This congressional briefing aimed to inform Congress about the need to pass the DeOndra Dixon INCLUDE Project Act of 2024 by the end of December. This legislation would authorize the National Institutes of Health's INCLUDE Project, launched in June 2018 to address the health and quality-of-life needs of individuals with Down syndrome. Initiated by GLOBAL in 2006, advocacy for a trans-NIH funding program led to the first congressional hearing on Down syndrome, aimed at accelerating scientific discoveries.

During the briefing, the panel highlighted the importance of: (I) including people with Down syndrome in research, (2) advancing innovative science through the INCLUDE Project, and (3) ensuring successful clinical trials with thoughtful planning and support.

The INCLUDE Project supports research into therapies for Alzheimer's disease, cancer, and other significant conditions, such as autoimmune disorders and diabetes. IINCLUDE also aims to increase the number of clinical trials for individuals with Down syndrome. Before this initiative, only two such trials existed; now, there are thirteen, thanks to better planning and support facilitating participant adherence.

The DeOndra Dixon INCLUDE Project Act, named in memory of GLOBAL's beloved Ambassador and Jamie Foxx's younger sister, DeOndra Dixon, will authorize Down syndrome research funding to elongate life and improve health outcomes for people with Down syndrome


